

## NEW BOSTON SCHOOL DISTRICT

### FOOD SERVICE MANAGEMENT

The New Boston School District shall provide a food service program. The program will offer meals that are nutritious, acceptable to students, and are affordable to families.

The Food Service Director is responsible to ensure the food service program meets all appropriate regulations of the US Department of Agriculture and the State Education Department (NHED) or any other entity with the proper jurisdiction over the program. It is the intent of the New Boston School District that the program remains self-funding. To meet that intent and continue a high-quality program, the School Board will review meal prices prior to the end of each school year or as recommended by the Food Service Director and/or Business Administrator.

**Free and Reduced Meal Price Program:** The Food Service program will offer the Free and Reduced price meal program as outlined by the US Department of Agriculture. The meal applications will be available at all schools and on the district websites throughout the school year. The Food Service program will work with the schools to ensure all students have access to the meal application. Parents/Guardians may appeal a negative determination by the Food Service Director to the SAU Business Administrator.

**Food Service Records:** The Food Service Director is responsible to maintain all food service records in accordance with US Department of Agriculture and NH Education Department (NHED) requirements.

**Food Service Sanitation:** Providing safe meals is of the utmost importance to the New Boston School District. The Food Service Program will comply with all sanitation requirements of the US Department of Agriculture, the US Food Code, and the State Department of Health and Human Services.

**Changes to Food Services Program:** The Food Service Director is responsible for communicating with building administrators any changes to the Food Service program that may impact school operations. Building administration will communicate any proposed changes to the school operations or the school schedule that may impact food service operations.

#### **Non-Discrimination Statement:**
